Using market based programming to reach WASH outcomes in emergencies

Background: why this training?

Cash and Voucher Assistance (CVA) and Market Based Programming (MBP) are becoming the new paradigm for humanitarian aid. While other sectors are already further advanced in this respect, the WASH sector is only now increasingly embracing this trend.

MBP in humanitarian settings, such as cash distributions, can provide support that is more tailored to individual needs. It shifts the focus from in-kind assistance to technical support, community engagement and the support of local economies to recover, rather than disrupting local markets with imports.

This is a foundation course for WASH Market Assessment and using Cash and Vouchers for WASH objectives. It is intended that this course will be useful for all RCRC Movement including National Societies, ICRC and IFRC staff and volunteers. It will specifically satisfy the <u>IFRC WASH</u> <u>competencies related to Tier A (demonstrate technical knowledge) for WASH and Cash and WASH Market Assessment.</u>

Who, when and where?

The workshop took place from 30th November – 3rd December 2023, face-to-face in Austrian Red Cross training centre in Litzlberg, Upper Austria. 25 staff and volunteers with WASH background (11f / 14m) participated from 7 Red Cross/Red Crescent societies (Austria, UK, Sweden, Germany, Lebanon, Norway). The facilitation team consisted of 5 trainers (1f, 4m) from Austria and Nepal.

Overall goals and learning objectives

This training is designed to make WASH ERU delegates understand the basic principles of Market based programming (MBP) and CVA (Cash& Voucher Assistance) and reflect on possible applications within their sphere of influence.

By the end of the course the participants were expected:

- To be able to demonstrate technical knowledge and to communicate demand side (e.g. cash and voucher assistance) or supply side (eg. local procurement) interventions for market sensitive WASH-programming.
- To be able to demonstrate knowledge of key concepts of market assessment and mapping for WASH activities, this will include engagement with the private sector.
- To have basic familiarisation with the key concepts in the 2021 Global Wash Cluster Market Based Programming in WASH: Technical Guidance for Practitioner.

Description of the training

After completing some mandatory and optional pre-reading (see Annex A for the list of prereading) an online webinar was held to introduce basic definitions ("What is market based programming?"; "What is a market?"; "What is CVA?") and clarify last logistical questions on Nov. 23rd. Participants were supposed to produce a summary of their pre-readings, using a method of their choice. 8 participants did so, sharing their posters, poems, AI-generated pictures and a song with the other participants.

The major focus in the face-to-face training was on market assessments and mapping, market based/ markets sensitive response options and their analysis and specifically on CVA response options.

Half of the group also got the chance to visit a local hygiene items store and speak to the management and a dedicated crisis manager of the respective chain (BIPA/ Rewe). Unfortunately, due to heavy snowfall, a similar opportunity for the other half of the group to speak to a local construction company had to be cancelled.

An agenda of the training "as run" can be found in Annex B.

The training was based on material that had been developed by the global WASH cluster for a 5 days training on the same topic, elements of which have been also used in an online training that had been already run by the Red Cross movement. As in those trainings, key ressources that were used in the training were the market based programming for WASH guideline and evidence papers for market based programming for water, sanitation and hygiene subsectors. The introduction session to CVA was customised for this training by Austrian RC based on Movement CVA material.

However, in contrast to those previous trainings, the current training replaced the hypothetical scenario with actual case studies to capitalise on the work by the RC/RC TWG on Cash&WASH: one completed case study (Nepal HH latrine reconstruction), one currently in draft stage (Lebanon hygiene NFI vouchers), one water trucking market study from Lebanon (done by other WASH actors), one based on material available from the ongoing Morocco EQ operation, and a real example of a pre-crisis-WASH-market assessment done by NepalRC. Apart from effectively utilizing work done by the TWG, this also allowed for opportunistically making use of the presence of participants from Lebanon, a facilitator from Nepal and participants that have just returned from a deployment in Morocco. Outcome



In general, the training received mostly good or excellent ratings across basically all dimensions in the final evaluation. The greatest potentials for improvements that could be read from those data are food (which will be difficult to change in this training venue). One key idea for improvement was related to the practical market assessment exercise: While the physical shop visit was found interesting, the possible crisis-scenarios in Austria and the whole market environment was seen as not very representative for the work of global RC WASH teams. As an alternative, participants

suggested to organize online interviews with market actors from countries of typical RC emergency deployments, such as Ugandan construction companies or Lebanese hygiene items wholesalers or vendors. We plan to pick up this idea for future trainings.
